DESCRIPTION

SikaPlast[®]-300 IQ is a Water reducing & plasticizing admixture for Concrete & Mortar utilizing Sika's 'Vis-coCrete[®]' polycarboxylate polymer technology (**3rd Generation**).

USES

1. Conventional Concrete (CVC).
2. Durable Concrete.
3. Pumped Concrete.

TECHNICAL INFORMATION

Concreting guidance

The standard rules of good concreting practice, concerning production and placing, are to be followed. Laboratory trials shall be carried out before concreting on site, especially when using a new mix design or producing new concrete components. Fresh concrete must be cured properly and curing applied as early as possible.

APPLICATION INFORMATION

Recommended dosage

(0.5 % - 2.5 %) by weight of total cementitious materials.

Dispensing

SikaPlast®-300 IQ is added to the gauging water or added with it into the concrete mixer. To take advantage of the high water reduction, a wet mixing time, which is depending on the mixing conditions and mixer performance, of at least 3 mins. per cubic meter after the admixture addition is recommended. SikaPlast®-300 IQ shall not be added to dry cement.

SikaPlast®-300 IQ can be used in conjunction with :

1. A suitable mix design has to be taken into account.

3. Over dosage of SikaPlast®-300 IQ with excess water will cause :
 - Increase in air entrainment.
 - Extend Initial & Final setting time.
